Stone 13x8x5 X on top 3 HES 234 on Southwest.
 1 1/2" capped Gal iron pipe along side stone.
 Orig. 24" now sawed 30" D-Fir stump S79E-15.8 ft. healed blaze.
 Orig. 30" now 36" uprooted D-Fir stump stood S2-55E-26.4 ft..
