3 I, KATHRYN D. HILTERBRANT, being first duly sworn, on oath,
 4 depose and say: That this Affidavit is for the purpose of
 5 supplying information of record pertaining to that certain
 6 Community Property Agreement executed by Howard E. Hilterbrant
 7 and Kathryn D. Hilterbrant, husband and wife, on May 27, 1966,
 8 and recorded with the County Auditor of Skamania County,
 9 Washington on JULY 30, 1985, under Document Number
 10 99682, and also pertaining to the Estate of Howard
 11 E. Hilterbrant, one of the parties to said agreement, who died on
 12 May 27, 1985, a resident of Clark County, Washington. It is
 13 intended that the statements set forth herein shall be considered
 14 representations of fact which may be relied upon by all persons
 15 dealing with the property of the parties including real property
 16 situated in Skamania County, Washington, described as follows:

11 Parcel 1:

12 That portion of the Southeast quarter of the
 13 Southeast quarter of the Northeast quarter of
 14 Section 27, Township 4 North, Range 7 E.W.M. more
 15 particularly described as follows:
 16 Commencing at the quarter corner on the East line
 17 of the said Section 27; thence West along the South
 18 line of the Northeast quarter of the said Section
 19 27 a distance of 200 feet to the initial point of
 20 the tract hereby described; thence West along the
 21 South line of the Northeast quarter of the said
 22 Section 27 a distance of 100 feet; thence North 220
 23 feet; thence East 100 feet; thence South 220 feet
 24 to the initial point.

25 TOGETHER WITH a right of way for a private road on,
 26 over and across other property of the grantors in
 27 the Southeast quarter of the Southeast quarter of
 28 the Northeast quarter of the said Section 27
 29 leading from the county road as now established to
 30 the tract of land hereby conveyed.

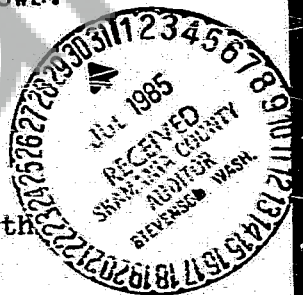
31 TOGETHER WITH an easement for a pipe line leading
 32 to a spring approximately 200 feet North of the
 33 above described real property, and the right to
 34 take water for domestic purposes only from the said
 spring, size of pipe to be limited to 3/4 inch.

34 Parcel 2:

35 That portion of the Southeast Quarter of the
 36 Southeast Quarter of the Northeast Quarter (SE1/4
 37 SE 1/4 NE1/4) of Section 27, Township 4 North,
 38 Range 7 E. W. M. more particularly described as
 39 follows:

40 Commencing at the quarter corner on the East line
 41 of the said Section 27; thence West along the South
 42 line of the NE 1/4 of the said Section 27 a
 43 distance of 300 feet to the initial point of the
 44 tract hereby described; thence West along the South
 45 line of the NE 1/4 of the said Section 27 a
 46 distance of 100 feet; thence North 220 feet; thence
 47 East 100 feet; thence South 220 feet to the initial
 48 point;

49 TOGETHER WITH a right of way for a private road and
 50 an easement for a pipeline and the right to take
 51 water from an existing spring as more particularly
 52 described in deed dated May 26, 1954, and recorded
 53 at page 101 of Book 39 of Deeds, Records of
 54 Skamania County, Washington; AND TOGETHER WITH an

9 Agreement.

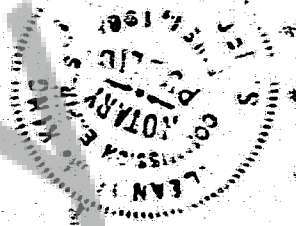
10 That all obligations of the community have been paid in full to
