

AMENDED NOTICE OF MINING LOCATION STATE OF WASHINGTON SKAMANIA COUNTY

MOUNTAIN GRANDEUR #7

MINING DISTRICT

NOTICE IS HEREBY GIVEN, That the undersigned locator has discovered a vein or lode of mineral bearing rock in place upon the unappropriated public domain within the State of Washington and in accordance with the laws of the United States, of the State of Washington and regulations of said mining district; has located, and does hereby locate a claim upon such vein or lode by posting, this notice of such discovery and location on a substantial post at the point of discovery, marked Post 1 and further described as follows:

Commencing at a post marked (Discovery Post) from thence 150 feet in a easterly direction, to the point of beginning, thence 300 feet in a northerly direction to a corner post marked No. 1, thence 1,500 feet in a westerly direction to a corner post marked No. 2, thence 300 feet in a southerly direction to a post marked No. 3, thence 300 feet in a southerly direction to a corner post marked No. 4, thence 1,500 feet in an easterly direction to a corner post marked No. 5, thence 300 feet in a cortherly direction to the point of beginning; hereby locating and intending to claim 300 feet in a northerly direction from discovery to the north end line; and 300 feet in the opposite direction from discovery to the south end line, and 150 feet in an easterly direction to the east end line, and 1350 feet in a westerly direction to the west end line, for the purpose of minning the same and claiming all surface rights, privileges and minerals, with all dips, spurs, angles and variations, and other rights granted by existing laws and customs.
