That your affiant is the lawful surviving spouse of DON C. GRAHAM, who died on August 4, 1985, in Vancouver, Clark County, State of Washington, leaving estate in said county and state; that the said DON C. GRAHAM, deceased, has provided for the disposition of all community property owned by himself and your affiant under a Community Property Agreement dated November 18, 1976, recorded November 18, 1976, under Auditor's File No. 83184, in Book 71, Page 937, records of Skamania County, Washington.

It is intended that the statements set forth herein shall be considered representations of fact which may be relied upon by all persons dealing with any and all, whether real or personal, community-held property of the deceased and your affiant.

First: That the parties of the aforescribed Community Property Agreement entered into no subsequent agreements which would have the effect of abrogating or nullifying said agreement.

Second: That all property owned by the decedent, DON C. GRAHAM, and his surviving spouse, ALMA GRAHAM, was community property; that the decedent left no separate property;

Third: That affiant knows of her own knowledge, and so states that each and all of the obligations against the marital community and against the estate of said decedent, have been paid in full or otherwise provided for.

Fourth: That the "decedent" had two (2) children, namely:

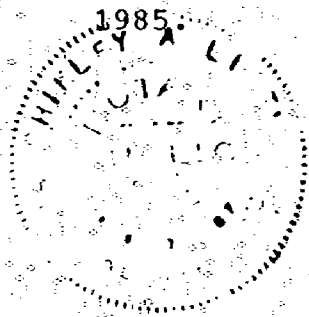
