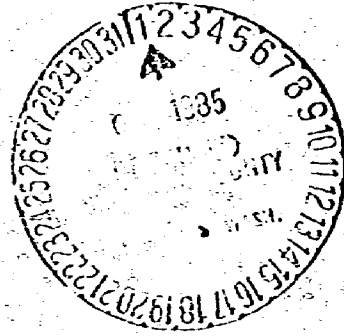

AFFIDAVIT IN SUPPORT

Third: That affiant knows of his own knowledge, and so states that each and all of the obligations against the marital community and against the estate of said decedent, have been paid in full or otherwise provided for.

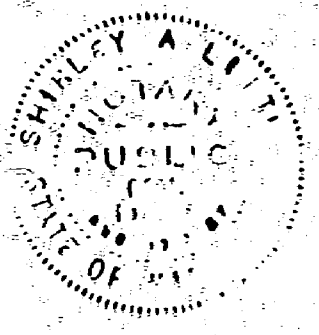
