

NOTICE OF TAX LIEN UPON REAL PROPERTY

I, Wilma J. Cornwall, Skamania County Treasurer, have this day determined pursuant to the authority vested in me by RCW 84.60.020 and 84.60.040 that it is necessary that the following described real property be, and the same heroby is, selected, designated and charged with unpaid personal property taxes as set forth, to wit:

## REAL PROPERTY LEGAL DESCRIPTION:

A portion of the West half of the SW1/4 of Sec. 5, Twp 1 N Range 5 E.W.M., described as follows:  
 BEGINNING at the Southwest corner of said Southwest Quarter; thence North 00 46' 52" East along the west line of said Southwest Quarter 834.82 feet; thence south 89 13' 08" East 660 feet, thence North 00 46' 52" East 244.79 feet; thence South 89 13' 08" East 330 feet to the TRUE POINT OF BEGINNING. Thence South 00 46' 52" West parallel with the West line of said Southwest Quarter 612.83 feet to the North right-of-way of the Belle Center Road; thence following said right-of-way line, along an arc of a 348.3 foot radius curve to the right, (the incoming tangent of which is South 89 45' 52" East) for an arc distance of 209.91 feet; thence South 49 49' 40" East, 155 feet more or less to the East line of the said West half of the SW1/4; thence Northerly along said East line 810 feet, more or less to a point S89 13' 08" East of the true point of beginning; thence North 89 13' 08" West, 330 feet, more or less to the true point of beginning. Containing 5 acres, more or less.  
 SUBJECT TO a 30 foot easement along the East line of the above described 5 acre parcel.


\* Penalties, interest and costs will accrue at the statutory rate after this date.
