CORRECTIVE EASEMENT

THIS CORRECTIVE AGREEMENT, made and entered into this 23rd day of August, 1985, between the STATE OF WASHINGTON, acting by and through the Department of Natural Resources, hereinafter called the "State," and S.D.S. COMPANY of Bingen, Washington and LONGVIEW FIBRE COMPANY of Longview, Washington, hereinafter called "S.D.S." and "Longview" WITNESSETH:

Whereas, on the 7th day of November, 1984, S.D.S., Longview and the State entered into an easement exchange, hereinafter called Original Easement, which was recorded in the records of Skamania County, Washington on the 26th day of November, 1984, in Volume 84 of Deeds, on pages 98-127 under Auditor's File No. 98520, and in the records of Klickitat County, Washington, on the 10th day of December, 1984, in Volume 229 of Deeds, pages 67-96 under Auditor's File No. 196474, and in the records of Clark County, Washington on the 27th day of December, 1984, on pages 163-192 under Auditor's File No. 8412270113. Said Original Easement is hereby corrected as follows:

The purpose of this document is to correct certain scrivener's errors in the original easement above described.

The corrections are as follows:

PAGE 1, Paragraph 1A.

Change lavender to "red" in reference to the color shown on Exhibit maps.

PAGE 1, Paragraph 1D and 1F.

Add "Clark" County along with Klickitat and Skamania.

Except as herein expressly corrected, the Original Easement shall be and remain in full force and effect.

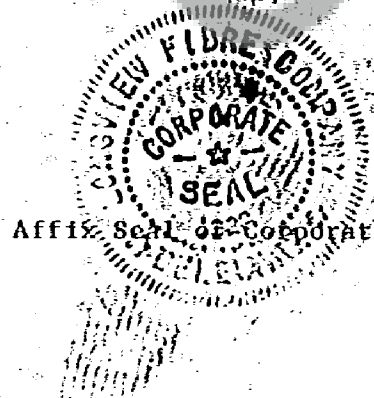
