## COMMUNITY PROPERTY AGREEMENT

## WITNESSETH:

WE HEREBY MUTUALLY AGREE that all of the property which shall hereafter be acquired by either of us, whether separately, jointly or otherwise, and of whatsoever nature, and wheresoever situate, shall be and it is hereby declared to be community property, and each of the parties do hereby convey and transfer

to the other and to their community, all such property hereafter acquired by either of them, even though the same be acquired in his or her separate estate; and

IT IS FURTHER AGREED that the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once, in the event of the death of CLYDE NORMAN ONEAL, while the said FLORENCE MAY ONEAL survives, be vested in FLORENCE MAY ONEAL, absolutely and in fee simple as her sole and separate property; and, in the event of the death of the said FLORENCE MAY ONEAL, while the said CLYDE NORMAN ONEAL survives, then the whole of the community property now owned by us or hereafter acquired by us, including all property which is changed or created by this agreement, shall at once vest in the said CLYDE NORMAN ONEAL absolutely and in fee simple as his sole and separate property.
