## COMMUNITY PROPERTY AGREEMENT

This COMMUNITY PROPERTY AGREEMENT entered into this day by and between Steven Don Graham, and Dianna Jean Graham, husband and wife, of Carson in Skamania County, State of Washington:

## WITNESSETH:

WHEREAS, the parties herete are the owners of certain real and personal property situated in the State of Washington; and

WHEREAS, it is contemplated by the parties hereto that in the future they may acquire additional property situated in the State of Washington; and


WHEREAS, it is the desire hereto that all of their property situated in the State of Washington shall pass to the survivor without delay or expense in the event of the death of either party;

It is FURTHER AGREED that the whole of the community now owned by us or hereafter acquired by us in the State of Washington,

including all property the status of which is changed or created by this agreement shall at once, the the even of the death of Steven Den Graham, while the said Dianna Jean Graham survives, be vested in Dianna Jean Graham absolutely and im fee simple as her sele and separate property; and in the event of the death of said Dianna Jean Graham, while the said Steven Don Graham survives, then the whole of the community property new ewned by us or hereafter acquired by us in the State of Washington, including all property the status of which is changed or created by this agreement, shall at once west in the said Steven Don Graham absolutely and in fee simple as his sele and separate preperty.

IT IS FURTHER AGREED that this community property agreement shall pertain only to real and personal property situated in the State of Washington.
