

EASEMENT SUPPLEMENT

THIS SUPPLEMENTAL AGREEMENT, made and entered into this 31st day of December, 1985, by and between CROWN ZELLERBACH CORPORATION, a Nevada corporation, herein called "Crown," and STATE OF WASHINGTON, acting by and through the Department of Natural Resources, herein called "State," WITNESSETH:

On the 7th day of March, 1974, Crown, granted an easement referred to herein as the Original Easement, to the State, said Easement being recorded in the records of Skamania County, Washington, on June 27, 1974, in Volume 66 of Deeds, pages 918-921 under Auditor's File No. 77764. Said Original Easement is hereby supplemented as follows:

I

- A. Crown for and in consideration of Two Thousand Seventy Five and No/100 Dollars (\$2075.00) hereby grants and conveys to State, its successors and assigns, a permanent easement upon, over, and along rights of way sixty (60) feet in width, over and across the NW1/4NE1/4 and N1/2NW1/4, Section 25, Township 2 North, Range 5 East, W.M., in Skamania County, Washington, being thirty (30) feet on each side of the centerline of a road located approximately as shown in red for existing road and yellow for new construction on the attached "Exhibit A."

Subject as to said lands to all matters of public record.

- B. The State shall construct the road shown in yellow on the attached "Exhibit A", provided, however, thirty (30) days prior to any construction reconstruction, or development, the State shall submit to Crown, for written approval, a complete and detailed plan of operation for the development of the right of way. The State's operations specified hereinabove shall be conducted in accordance with the provisions of the approved Plan of Operation in force at the time of the commencement of said operations and the State shall provide for the examination of the right of way with Crown's representative, before any construction reconstruction, or development is commenced.

Except as herein supplemented all of the terms, conditions and reservations of the Original Easement shall remain in full force and effect.

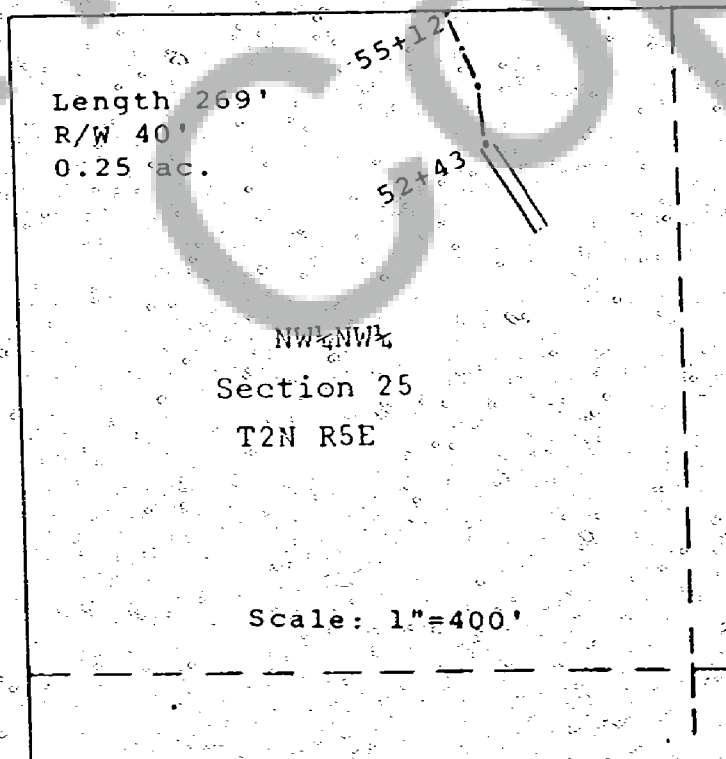
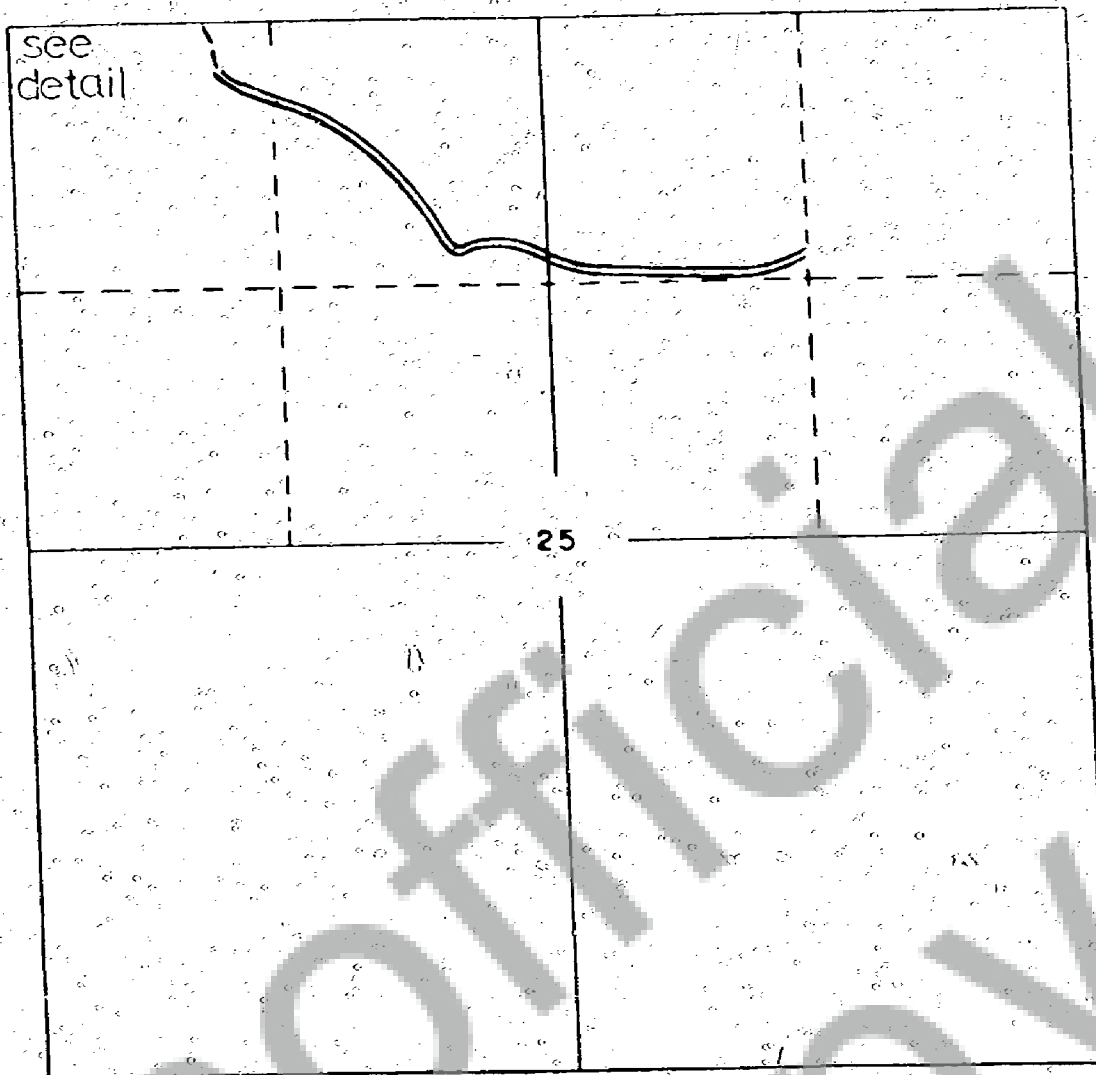
