5.1 Maintenance of Casualty Insurance. 5.3 Application of Proceeds. Borrower shall promptly notify Lender of any loss or damage to the Mortgaged Property. Lender may, at its election apply the proceeds to the reduction of the Indebtydness or the restoration and repair of the Mortgaged Property. If Lender elects to apply the proceeds to restoration and repair, Borrower shall repair and/or replace the damaged or destroyed improvements in a manner satisfactory to Lender. Lender shall, upon satisfactory proof of such expenditure, pay or reimburse Borrower from the proceeds for the reasonable cost of repair or restoration if Borrower is not in default hereunder. Imposition of Tax by State

6.2 Effect of Taxes. If any state tax to which this section applies is enacted after the date of this Mortgage, this shall constitute an event of default unless the following conditions are met:

Borrower may lawfully pay the tax or charge imposed by the state tax; and

- Borrower pays or offers to pay the tax or charge within 30 days after notice from Lender that the tax law has been enacted.
