TERMINATION OF LEASE BY  
MUTUAL AGREEMENT

This agreement is made and entered into between Water Front Recreation, Inc., a Washington corporation, hereafter referred to as Lessor, and William Crimmel, having his principal place of residence at 100 Pine Street, Kelso, Washington 98629, hereafter referred to as Lessee.

RECITALS

1. Lessor and Lessee have entered into a lease entitled Cabin Site Lease, dated September 4, 1983, of the following described real property:

Cabin site number 117 of the North Woods, being part of Government Lots 4 and 8, Section 26, Township 7 North, Range 6 East, W.M., Skamania County, Washington, SUBJECT, however to an easement for right of way for access road acquired by the United States of America, United States Forest Service.

Said real property is sometimes also known as said cabin site as shown on the plat and survey entitled Record Survey for Waterfront Recreation, Inc. dated May 14, 1971, on file and of record under Auditor's File No. 73635, at page 306 of Book "J" of Miscellaneous Records of Skamania County, Washington.

2. The lease in Section 8 concerning termination provides that on default in the payment of rent, or on default in the performance of any terms or conditions of the lease by Lessee, Lessor may, if Lessor so elects, terminate the lease upon giving 60 days written notice.
3. The terms and conditions of the lease have been breached by Lessee.

In consideration of the mutual covenants contained herein, the parties agree as follows:

Lessor elects to terminate the Cabin Site Lease with Lessee in its entirety, effective immediately, and Lessee does hereby give, grant and convey to Lessor all the right and

interest of Lessee to possession of the premises described above, together with all right, title and interest to any personal property, including but not limited to any structure thereon, presently located on the premises.

All of the terms and conditions herein contained shall be binding on and inure to the benefit of the parties, and the respective heirs, legatees, devisees, administrators, executors, successors and assigns of the parties.
