CONTRACTOR OF THE PROPERTY OF

A portion of the South half of the Southwest Quarter of Section 34, Township 2 North, Range 5 East of the Willamette Meridian, Skamania County, Washington, described as follows:

Beginning at a point on the South line of the South half of the Southwest Quarter of Section 34, South 89° 30' 12" East 73.95 feet from an iron pipe and brass cap at the Southwest Corner of Section 34, to the point of beginning; thence continuing South 89° 30' 12" East 188.85 feet;

Thence North 32° 00' 00" East 33.39 feet to the center of the Salmon Falls County Road, and the beginning of a 60 foot easement centerline;

Thence North 32° 00' 00" East 233.44 feet;

Thence along the arc of a 300 foot radius curve to the right for an arc distance 68.94 feet;

Thence North 45° 10' 00" East 16.62 feet;

Thence along the arc of a 500 foot raduis curve to the left for an arc distance of 157.08 feet;

Thence North 27° 10' 00" East 33.51 feet;
