POWER OF ATTORNEY

6. To bargain for, buy and deal in property and goods of every description;

7. To grant, sell, mortgage, pledge, consign, lease, hypothecate and in any and every manner deal in and with my property, both real and personal;

8. To advance her funds on my behalf and to borrow any sums of money on such terms and at such rate of interest at to my said attorney may seem proper and to give security for the repayment of the same;

9. To make and deliver any conveyances, contracts, covenants, and other instruments, undertakings or agreements, either orally or in writing, of whatever kind and nature which my said attorney in her discretion shall deem to be for my best interests;

13. To withdraw any monies deposited with any bank, mutual savings bank or savings and loan association in my name or in the name of myself and any other person or persons


and generally to do any business with any financial institution on my behalf;


