A tract of land located in Section 28, Township 2 North, Range 5 East of the Willamette Meridian, Skamania County, Washington, described as follows:

BEGINNING at the North Quarter corner of Section 28, Township 2 North, Range 5 East of the Willamette Meridian; thence along the North-South centerline South $08^{\circ} 26' 45''$ East 1,025.00 feet to a point; thence South $89^{\circ} 43' 23''$ West 50.00 feet to a pipe at point of beginning; thence North $89^{\circ} 43' 17''$ East 266.99 feet; thence South $27^{\circ} 37' 18''$ East 746.52 feet to Westerly boundary of LaBarre County Road; thence along road boundary South $45^{\circ} 18'$ West 169.78 feet; thence through a curve to the left with a radius of 411.97 feet; through a central angle of $5^{\circ} 45'$ a distance of 70.10 feet; thence South $35^{\circ} 33'$ West 66.73 feet; thence through a curve to the right with a radius of 351.97 feet through a central angle of $8^{\circ} 45'$ a distance of 54.57 feet; leave road and thence North $2^{\circ} 04' 35''$ East 411.26 feet to a pipe; thence North $36^{\circ} 50' 04''$ West 647.20 feet to the point of beginning.

TOGETHER WITH the right of ingress, egress and utilities in common with others, over and across Sievers Road, a private road, adjoining the North line of this tract and connecting with LaBarre Road.
