During the 1986 assessment year (9/1/85 to 9/1/86) two man days labor was performed on the claim. The work consisted of removing overburden washed in by high water and extracting material from a Quartz vein for analysis. The labor was performed by Russell A. Niblock and Ted Martin

With labor estimated at \$60.00 per man day assessment work was \$ 120.00 excluding indirect costs. This Firlock II claim is contiguous with the original Firlock Lode claim (see County Auditor file # 87160 Mines Vol. M, P 963-64; B.L.M. serial # ORMC 8278, T 9 N, R 9 E, W.M.) and the aggregate expenditure on the contiguous claims was \$ 360.00.

It is planned to substantially increase prospecting and mining activities after the U.S. Forest Service Boulder Creek timber sale and road are completed. The road provides excellent access to the claim with economical advantages.
