AMENDMENT TO DEED GRANTING EASEMENT

BROUGHTON LUMBER CO., a Washington corporation, of Underwood, Skamania County, Washington, owners of the land next below described, and herein amend that certain Deed Granting Easement between BROUGHTON LUMBER CO., Grantors, and TERRY L. HEINDL and MARY K. HEINDL, dated the 21st day of July, 1978, recorded the 24th day of July, 1978, in Book 75 of Deeds, pages 161-162, under Skamania County Auditor's File No. 86064, excise tax receipt No. 6020, concerning an easement across property situate in Skamania County, Washington, as follows:

An easement of 16 feet in width and 12 feet in height for ingress, egress and utilities described as follows:

Commencing at a point on the northeast corner of the West Half of the Northeast Quarter of the Northeast Quarter of Section 15, Township 3 North, Range 9 East, W. M., which point lies on the West line of Jessup Road; thence South along Jessup Road 100 feet, more or less, to the point of beginning of this easement; thence northwesterly along an existing road to a point which intersects the section line common to Sections 10 and 15 and is 330 feet, more or less, from the northeast corner of the West Half of the Northeast Quarter of the Northeast Quarter of Section 15, Township 3 North, Range 9 East, W. M., and the terminus of this easement.

In all other respects not herein expressly amended, the terms of the said Deed Granting Easement dated July 21, 1978, shall remain unchanged and in full force and effect.

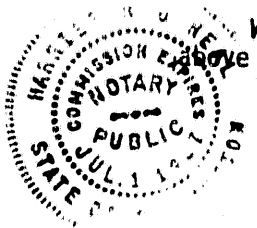
