1. TIMBER: The Purchaser hereby covenants and agrees not to cut or remove from the aforedescribed real estate any merchantable timber situate thereon without first receiving the written consent of the Seller. It is agreed this restriction shall not prevent Purchaser from using down timber for firewood in the dwelling situate thereon.
