All payments to ce made hereunde shall be made at or at such other place as the seller may direct in writing.

(1) The purchaser assumes at f agrees to pay before delinquency all taxes and assessments that may as between grantor and grantee hereafter become a lien on said rail estate; and if by the terms of this contract the purchaser has assumed payment of any mortgage, contract or other encumbrance, or has assumed payment of or agreed to purchase subject to, any taxes or assessments now a lien on said real estate, the purchaser agrees to pay the same before delinquency.

(2) The purchaser agrees, unt l the purchase price is fully paid, to keep the buildings now and hereafter placed on said real estate insured to the actual cash value th reof against loss or damage by both fire and windstorm in a company acceptable to the seller and for the seller's benefit, as his interest may appear, and to pay all premiums therefor and to deliver all policies and renewals thereof to

(3) The purchaser agrees that full inspection of said real estate has been made and that neither the seller nor his assigns shall be held to any covenant respecting the condition of any improvements thereon nor shall the purchaser or seller or the assigns of either be held to any covenant or agreement for alterations, improvements or repairs unless the covenant or agreement relied on is contained herein or is in writing and attached to and made a part of this contract.

In case any part of said real estate is taken for public use, the portion of the condemnation award remaining after payment of reasor ble expenses of procuring the same shall be paid to the seller and applied as payment on the purchase price herein unless the celler elects () allow the purchaser to apply all or a portion of such condemnation award to the rebuilding or restoration of any improvements damage | by such taking. In case of damage or destruction from a peril insured against, the proceeds of such insurance remaining after payment of the reasonable expense of procuring the same shall be devoted to the restoration or rebuilding of such improvements within a reasonable time, unless purchaser elects that said proceeds shall be paid to the seller for application on the nurchase price herein. purchase price herein.


