SCHEDULE C

The land referred to in this policy is situated in the State of Washington
County of Skamania

and is described as follows:

That portion of the Southwest quarter of the Southeast quarter of Section 20, Township 3 North, Range 10 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at the quarter corner on the South line of the said Section 20; thence following the South line of the said Section 20 East 174.65 feet; thence North $12^{\circ} 31'$ West 359.42 feet to an intersection with the Southerly right-of-way line of the county road known and designated as the Cook-Underwood Road; thence South $56^{\circ} 56'$ West following the Southerly right-of-way line of said road 135.3 feet to a point on the West line of the Southwest quarter of the Southeast quarter of the said Section 20; thence South 276.14 feet to the point of beginning.
