Property located in skamania County State of Washington:

That portion of the southeast quarter of Section 17. Township 1 North. Range 5 east of the Willamette Meridian Skamania County. Washington described as follows

BEGINNING at a point on the west line of said southeast quarter of Section 17, Township 1 North, Range 5 East, Willamette meridian south 01° 26' 00" west, 3607 13 feet from a concrete monument at the north quarter corner of said Section 17 said point of beginning being the southwest corner of the "Peet" Tract, as shown on recorded survey in volume 1 at page 16; thence north 86° 18'34" east along the south line of said "Peet" tract 655 72 feet; thence north 02° 18' 00" west 60 00 feet thence north 87° 42' 00" east, 96.26 feet thence leaving said south line, south 02° 18' 00" east, 780 feet more or less, to the north right of way line of state highway #14 thence westerly along said north line, 880 feet more or less, to the west line of the southeast quarter of section 17; thence north 01° 26' 00" east along said west line 505 feet more or less to the point of beginning:

TOGETHER WITH and subject to a 60 foot easement for ingress, egress and utilities, the centerline of which is described as follows:
