Notice is hereby given that Merle L. Blankenship of Cowlitz county, State of Washington, claims a lien upon 100,680 Bdf, or 1,193,160<sup>lbs</sup> of Logs, being about 540 Logs in quantity, which were cut or manufactured in Skamania county, State of Washington, are marked thus Brand 2-11 yellow paint and are now lying in Columbia Vista Storage for labor performed upon and assistance rendered in Transporting said Logs; that the name of the owner or reputed owner is Columbia Vista Mill; that Joe Zumstein Log employed said Merle L. Blankenship to perform such labor and render such assistance upon the following terms and conditions, to wit:

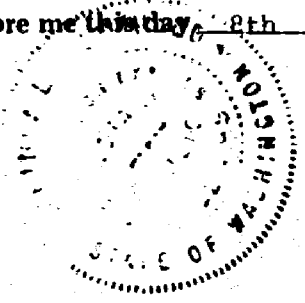
The said Joe Zumstein Log agreed to pay the said Merle L. Blankenship for such labor and assistance State Rate 4.88 Per 1,000 lbs; that said contract has been faithfully performed and fully complied with on the part of said Merle L. Blankenship, who performed labor upon and assisted in Transporting said Logs for the period of 28 days; that said labor and assistance were so performed and rendered upon said Joe Zumstein Log between the 23 day of November and the 20 day of December; 1986 and the rendition of said service was closed on the 20 day of December, and thirty days have not elapsed since that time; that the amount of claimant's demand for said service is \$5,822.<sup>62</sup>/<sub>100</sub>; that no part thereof has been paid except NONE, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$5,822.<sup>62</sup>/<sub>100</sub>, in which amount he claims a lien upon said Logs + other Properties. The said Merle L. Blankenship also claims a lien on all said Logs + other Properties now owned by said Columbia Vista or Joe Zumstein Log of said county to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.
