Notice is hereby given that Bryon S. Weese of Clark county, State of  
Washington, claims a lien upon 3800 B.F. <sup>LOGS OR</sup> ~~of other properties~~ being about 48

in quantity, which were cut or manufactured in Skamania county, State of Washington, are marked  
thus <sup>Brand</sup> BT yellow paint, and are now lying in Boise Cascade RAFT, for labor performed upon and assistance

rendered in Transporting said Logs; that the name of the owner or reputed owner is Boise  
Cascade; that Joe Zumstein Logging employed said Bryon S. Weese to perform such labor  
and render such assistance upon the following terms and conditions, to wit:

The said Joe Zumstein Logging agreed to pay the said Bryon S. Weese for such labor and assistance  
State Rate; that said contract has been faithfully performed and fully complied with on the part of said  
Bryon S. Weese, who performed labor upon and assisted in Transporting said Logs  
for the period of 1 Day; that said labor and assistance were so performed and rendered upon said  
Joe Zumstein Logging between the 4 day of Dec. 1986 and the 5 day of Dec. 1986;  
and the rendition of said service was closed on the 5 day of Dec. 1986, and <sup>SIXTY</sup> ~~thirty~~ days have not elapsed  
since that time; that the amount of claimant's demand for said service is \$194.80; that no part thereof

has been paid except NONE, and there is now due and remaining unpaid thereon, after deducting all  
just credits and offsets, the sum of \$194.80, in which amount he claims a lien upon said <sup>LOGS OR</sup> ~~other properties.~~

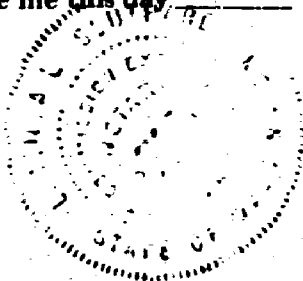
The said Bryon S. Weese also claims a lien on all said <sup>LOGS OR</sup> ~~other properties~~ now owned by said Boise Cascade
