Notice is hereby given that HARLIE CASSEL of CHARK county, State of Washington, claims a lien upon 542300 ^{LBS} 49590 B F. of logs ^{OTHER} ~~PROPERTY~~, being about 273 in quantity, which were cut or manufactured in SKAMANIA county, State of Washington, are marked thus Z 11, and are now lying in Col Vista Corp, for labor performed upon and assistance rendered in TRANSPORTING said logs; that the name of the owner or reputed owner is Col Vista Corp. Zumstein Logging, that Zumstein Logging employed said HARLIE CASSEL to perform such labor and render such assistance upon the following terms and conditions, to wit:

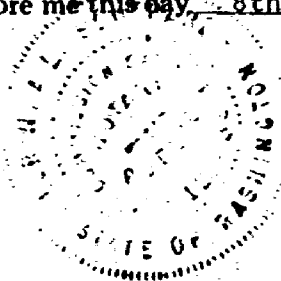
The said Zumstein Logging agreed to pay the said HARLIE CASSEL for such labor and assistance \$4.88 per 1000 lbs; that said contract has been faithfully performed and fully complied with on the part of said HARLIE CASSEL, who performed labor upon and assisted in TRANSPORTING said logs for the period of 30 DAYS; that said labor and assistance were so performed and rendered upon said Zumstein Logging between the 1 day of Dec. 1986 and the 30 day of Dec 1986; and the rendition of said service was closed on the 30 day of Dec 1986, and thirty days have not elapsed since that time; that the amount of claimant's demand for said service is 2646.42; that no part thereof has been paid except NONE, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of 2646.42, in which amount he claims a lien upon said logs ^{OTHER} ~~PROPERTY~~ ZUMSTEIN. The said HARLIE CASSEL also claims a lien on all said logs ^{OTHER} ~~PROPERTY~~ now owned by said Columbia Vista Corp. Zumstein Logging of said county to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.
