Notice is hereby given that HARLIE CASSEL of CLARK county, State of Washington, claims a lien upon 8330 B.F. of logs <sup>OTHER PROPERTIES</sup>, being about 37 logs

in quantity, which were cut or manufactured in SKAMANIA county, State of Washington, are marked thus 27, and are now lying in COL VISTA CORP., for labor performed upon and assistance rendered in TRANSPORTING said logs; that the name of the owner or reputed owner is COL VISTA ZUMSTEIN LOGGING that ZUMSTEIN LOGGING employed said HARLIE CASSEL to perform such labor and render such assistance upon the following terms and conditions, to wit:

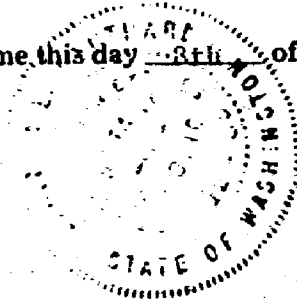
The said ZUMSTEIN LOGGING agreed to pay the said HARLIE CASSEL for such labor and assistance STATE RATE; that said contract has been faithfully performed and fully complied with on the part of said HARLIE CASSEL, who performed labor upon and assisted in TRANSPORTING said logs for the period of 2 DAYS; that said labor and assistance were so performed and rendered upon said ZUMSTEIN LOGGING between the 25<sup>th</sup> day of NOV. 1986 and the 16<sup>th</sup> day of NOV. 1986; and the rendition of said service was closed on the 25<sup>th</sup> day of NOV. 1986, and SIXTY days have not elapsed since that time; that the amount of claimant's demand for said service is 560.50; that no part thereof has been paid except NONE, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of 560.50, in which amount he claims a lien upon said logs <sup>OTHER PROPERTIES</sup>. The said HARLIE CASSEL also claims a lien on all said logs <sup>OTHER PROPERTIES</sup> now owned by said COLUMBIA VISTA & ZUMSTEIN LOGGING of said county to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.
