Notice is hereby given that Elmer Adams of Cowlitz county, State of

Washington, claims a lien upon 500,000 B.F. of LOGS, being about 2000 LOGS

in quantity, which were cut or manufactured in SKAMANIA county, State of Washington, are marked

thus Brand 29 + Yellow Paint, and are now lying in SMURFIT MILL for labor performed upon and assistance

rendered in TRANSPORTING said LOGS; that the name of the owner or reputed owner is SMURFIT

MILL; that Joe Zumstein Logging Co. employed said Elmer Adams to perform such labor

and render such assistance upon the following terms and conditions, to wit:

The said Joe Zumstein Logging Co. agreed to pay the said Elmer Adams for such labor and assistance  
\$5.00 PER 1000 LBS.  
\$3.20 PER 1000 LBS.; that said contract has been faithfully performed and fully complied with on the part of said

Elmer Adams, who performed labor upon and assisted in TRANSPORTING said LOGS

for the period of 59 Days; that said labor and assistance were so performed and rendered upon said

Joe Zumstein Logging Co. between the 3 day of NOV 1986 and the 23 day of DEC 1986;

and the rendition of said service was closed on the 23 day of DEC 1986, and SIXTY (60) days have not elapsed

since that time; that the amount of claimant's demand for said service is \$19,120.56; that no part thereof

has been paid except NONE, and there is now due and remaining unpaid thereon, after deducting all

just credits and offsets, the sum of \$19,120.56, in which amount he claims a lien upon said LOGS.

The said Elmer Adams also claims a lien on all said LOGS now owned by said SMURFIT MILL

of said county to secure payment for the work and labor performed in obtaining or securing the said logs, spars,

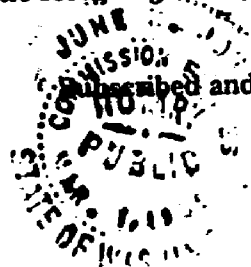
piles or other timber, lumber or shingles herein described.
