Notice is hereby given that Elmer Adams of Cowlitz county, State of Washington, claims a lien upon 48,000 B.F. of LOGS & OTHER PROPERTIES, being about 200 LOGS in quantity, which were cut or manufactured in SKAMANIA county, State of Washington, are marked thus Brand Z 11 + Yellow Point, and are now lying in Columbia Vista Storage, for labor performed upon and assistance rendered in TRANSPORTING said LOGS; that the name of the owner or reputed owner is Columbia Vista Mill; that Joe Zumstein Logging Co. employed said Elmer Adams to perform such labor and render such assistance upon the following terms and conditions, to wit:

The said Joe Zumstein Logging Co. agreed to pay the said Elmer Adams for such labor and assistance State Rate \$4.88 PER 1000 LBS.; that said contract has been faithfully performed and fully complied with on the part of said Elmer Adams, who performed labor upon and assisted in TRANSPORTING said LOGS for the period of 15 DAYS; that said labor and assistance were so performed and rendered upon said Joe Zumstein Logging Co. between the 6 day of Dec 1986 and the 19 day of Dec. 1986; and the rendition of said service was closed on the 23 day of Dec 1986, and Sixty (60) days have not elapsed since that time; that the amount of claimant's demand for said service is \$2419.75; that no part thereof has been paid except NONE, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$2419.75, in which amount he claims a lien upon said LOGS & OTHER PROPERTIES. The said Elmer Adams claims a lien on all said LOGS & OTHER PROPERTIES now owned by said Joe Zumstein Logging Co. & Columbia Vista Mill of said county to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles or other timber, lumber or shingles herein described.

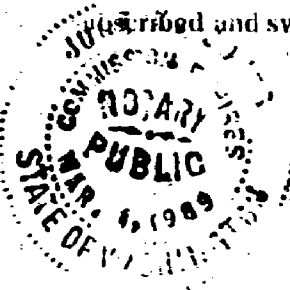
