GRANTOR(S) THELMA TOMBLESON

for and in consideration of the sum of one  
(\$ 1.00) Dollars, to us in hand paid, and in further consideration of the general public  
welfare, do by these presents grant, convey and dedicate to SKAMANIA County,  
State of Washington, for the use of the public as a county road and appurtenances the following de-  
scribed real property in the County of SKAMANIA, State of Washington:

### TOMBLESON ROAD

COMMENCING AT A POINT FOUND BY STARTING AT THE SOUTHEAST CORNER OF SECTION 27,  
TOWNSHIP 3 NORTH, RANGE 8 EAST OF THE WILLAMETTE MERIDIAN, SKAMANIA COUNTY, WASH-  
INGTON AND RUNNING THENCE WEST ALONG THE SOUTH LINE OF THE SECTION 942.9 FEET;  
THENCE NORTH 23° 59' EAST 39.84 FEET TO THE TRUE POINT OF BEGINNING OF THIS DES-  
CRPTION, WHICH POINT IS THE NORTHEAST CORNER OF THAT PARCEL ACQUIRED BY JOHN  
A. DUNOVEN, ET UX, BY INSTRUMENT RECORDED IN BOOK 65 ON PAGE 910; THENCE CONTIN-  
UING NORTH 23° 59' EAST A DISTANCE OF 40 FEET, MORE OR LESS, TO THE SOUTHEAST

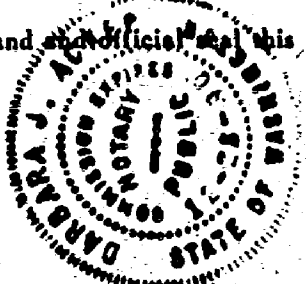
