EXHIBIT "A"

BEGINNING at an iron stake on the Northerly line of State Highway No. 8 as the same existed on October 1, 1943, at a point 10 chains East of the West line of the Robbins D. L. C. in Section 27, Township 3 North, Range 8 East of the Willamette Meridian; thence North 347 feet; thence North 72°15' West 178.2 feet to the Easterly line of the right of way of the Home Valley Road at an iron stake; thence South 75°14' West along the Easterly line of the said right of way of said Home Valley Road a distance of 274.6 feet to an iron stake; thence South 09° West 128.8 feet to the Northerly line of said Highway No. 8 as aforesaid at an iron stake; thence South 66°31' East along the Northerly line of said State Highway No. 8 a distance of 491 feet to the Place of Beginning.
