ASSIGNMENT OF MORTGAGES AND DEEDS OF TRUST

Assignment of mortgages and deeds of trust made this 26th day of February, 1987, by U.S. Creditcorp, an Oregon corporation, to U.S. Bancorp Consumer Services, Inc., an Oregon corporation,

WHEREAS, U.S. Creditcorp was voluntarily dissolved effective February 11, 1986, and was issued a Certificate of Withdrawal by the State of Washington dated June 19, 1986;

WHEREAS, U.S. Creditcorp has heretofore assigned to U.S. Bancorp Consumer Services, Inc., all of U.S. Creditcorp's loan receivables; and

WHEREAS, many of said loan receivables are secured by mortgages and deeds of trust;

NOW, THEREFORE, for valuable consideration, U.S. Creditcorp, an Oregon corporation, hereby grants, conveys, assigns and transfers to U.S. Bancorp Consumer Services, Inc., an Oregon corporation, and its successors and assigns, all of U.S. Creditcorp's right, title, and interest in each and every deed of trust and mortgage in which U.S. Creditcorp, as of February 11, 1986, was the beneficiary or mortgagee, specifically including, but not necessarily limited to, the deeds of trust and mortgages identified on the schedule attached hereto, together with any and all notes secured by said deeds of trust and mortgages, and all sums due thereunder. U.S. Bancorp Consumer Services, Inc., shall be entitled to take any action, including instituting any proceedings, which U.S. Creditcorp would otherwise be entitled to take with respect to said mortgages and deeds of trust.

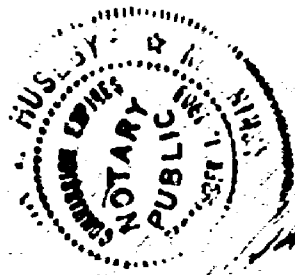
