Notice of Location of Placer Claim

STATE of Wash County of Skamania Star MT Mining District.

NOTICE HEREBY IS GIVEN That the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a placer deposit of locatable minerals upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district; and, in accordance with the laws of the United States and the State of Oregon, have located and hereby do locate a placer claim of 20 acres by posting this notice of location on a post or monument in a conspicuous place inside the boundaries of the claim. The claim is named the Star MT #1

Claim, which is described as follows (fill out one of the two sections below):

If claim is on surveyed land:

This claim comprises the 20 acres of Section 4, Township T5N, Range R5E, of the Willamette Meridian.

thence 330 feet in a Easterly direction to a post marked No. 4;

thence 330 feet in a Easterly direction to a post marked No. 5;

thence 1320 feet in a Northerly direction to a post marked No. 6;

thence _____ feet in a _____ direction to a post marked No. 7;

thence _____ feet in a _____ direction to a post marked No. 8;

thence 330 feet in a Westerly direction to the post marked No. 1.
