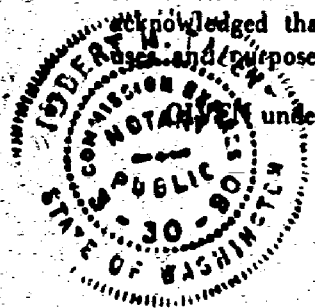

A right-of-way as required for the county road known and designated Gropper Road (County Road No. 20640), located in the west one half (W 1/2) of Section 36, Township 3 North, Range 7 East W.M. in Skamania County, Washington.

CENTERLINE DESCRIPTION

Beginning at the county monument marking the center quarter corner of Section 36, Township 3 North, Range 7 East of the Willamette Meridian; thence S86°15'43"W 1395.41 feet to Sta. 0+00, the initial point of the centerline therein described. Said Sta. 0+00, new Gropper Road alignment, equals Sta. 49+51.78 of Loop Road. Thence N11°31'01"E 89.25 feet to P.C. Sta. 0+89.25, being the P.C. of a 100 foot radius curve to the right; thence following said curve to the right through a central angle of 69°48'02" 121.83 feet; thence N81°19'03"E 188.92 feet to Sta. 4+00. Said station being N84°37'44"W 1109.85 feet from the county monument marking the center quarter of said Section 36.

RIGHT-OF-WAY DESCRIPTION

All that portion of the grantor's property lying north of Loop Road, south of Gropper Road as existing in 1986 and westerly and northerly of a line drawn as follows: Beginning at a point 30 feet right from Sta. 0+19 on the above described centerline. Thence parallel to and 30 feet right of said centerline to Sta. 4+00.

Containing a total of 0.48 acre and being a net additional right-of-way of 0.31 acre more or less.
