

EXECUTOR'S DEED

Deed made April 17, 1987, between AVARY SKAALHEIM, of Stevenson, Skamania County, Washington, herein referred to and acting as Executor of the Estate of Tari D. Skaalheim, deceased, and AVARY SKAALHEIM, of Stevenson, Skamania County, Washington, herein referred to as grantee.

The parties recite and declare that:

1. On May 4, 1978, Tari D. Skaalheim executed her will disposing of all of her property. Tari D. Skaalheim died on February 19, 1986, and her will was duly admitted to probate by proper order of the Superior Court of the County of Skamania, State of Washington.

2. By the terms of the will, in the fourth paragraph, certain residuary property rights and interest were devised to said grantee.

3. The will conferred on Avary Skaalheim, as executor, general authority to sell and dispose of any portion of the estate and to execute conveyances thereof.

4. The interest in the real estate of Tari D. Skaalheim vested or to be vested in grantee by virtue of the fourth paragraph of the will is of the reasonable value of Twenty-two Thousand (\$22,000.00) Dollars.

In consideration of the premises the executor of the Estate of Tari D. Skaalheim, deceased, conveys to grantee all that certain land and premises described as follows:

That portion of Government Lots 4 and 9 in Section 36, Township 3 North, Range 7 1/2 East of the Willamette Meridian, Skamania County, Washington, more particularly described as follows:

Beginning at a point 287 feet East and 417.5 feet North of the intersection of the North line of the Henry Shepard D.L.C. and the Second Guide Meridian East; thence North 417.5 feet; thence East 417.5 feet; thence South 417.5 feet; thence West 417.5 feet to the point of beginning;

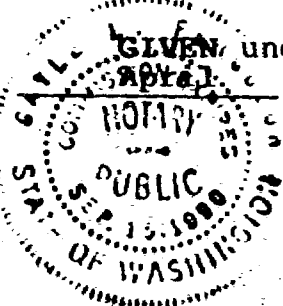
