KNOW ALL PERSONS BY THESE PRESENTS, That I, the undersigned, a resident of Portland, Oregon, do hereby make, publish and declare this document to be my Last Will and Testament, and do by these presents hereby revoke all wills and codicils which I may have previously made.

FIRST: I give, devise and bequeath all of my property and estate, of whatever kind or nature and wherever situated, to my husband, BERNARD R. WOLFF, provided he shall survive me.

SECOND: In the event my husband shall not survive me, then I give, devise and bequeath all of my property and estate unto my children, CHRISTOPHER M. WOLFF and SCOTT J. WOLFF, share and share alike, and in the event that either of my children predecease me, then to the surviving issue of any deceased child by right of representation.

THIRD: In the event of the death of myself and my said husband in a common disaster or under circumstances which create doubt as to which of us shall have survived the other, then I direct that my said husband shall be presumed to have predeceased me.

FOURTH: My Personal Representative shall have the discretionary power to sell any and all of my real or personal property upon minimum legal terms, either at public or private sale, without citation or publication of notice thereof, for the purpose of paying creditors' claims, costs of administration or for facilitating distribution of my estate.

FIFTH: I nominate and appoint my husband, BERNARD R. WOLFF, as Executor of this Will and Personal Representative of my estate. In the event he is unable or unwilling to act in this capacity, then I nominate and appoint my son, CHRISTOPHER M. WOLFF, as alternate Executor and Personal Representative. No bond or other surety shall be required of either person.
