



THIS MATTER having come on regularly for hearing before the above-entitled Court; the Plaintiff appearing by and through its attorney, D. Jean Shaw; the Defendant not appearing personally or by anyone in his behalf and having been adjudged to be in default as evidenced by the entry of an Order of Default on file herein; and the Court having been advised in the premises and having before it the files and records herein, now, therefore, it is hereby

ORDERED, ADJUDGED AND DECREED that the Plaintiff is hereby awarded a Judgment against the Defendant PETER W.
