LOWRY, FOR AND IN CONSIDERATION OF THE LOVE AND AFFECTION WE HAVE ONE FOR THE OTHER, DO HEREBY MUTUALLY AGREE THAT ALL REAL AND PERSONAL PROPERTY WHICH WE NOW OWN SEPARATELY, JOINTLY OR OTHERWISE, AND WHERESOEVER SITUATED, SHALL BE AND IT IS HEREBY DECLARED TO BE THE COMMUNITY PROPERTY OF THE PARTIES, AND EACH OF THE PARTIES DOES HEREBY AND TRANSFER TO THE OTHER PARTY AND TO THEIR MARITAL COMMUNITY, ALL PROPERTY NOW OWNED BY THEM, EVEN THOUGH THE SAME WAS ACQUIRED IN HIS OR HER SEPARATE ESTATE, AND

WE HEREBY MUTUALLY AGREE THAT ALL OF THE PROPERTY WHICH SHALL HEREAFTER BE ACQUIRED BY EITHER OF US, WHETHER SEPARATELY, JOINTLY OR OTHERWISE, AND OF WHATSO-EVER NATURE AND WHERESOEVER SITUATED, SHALL BE AND IS HEREBY DECLARED TO BE THE COMMUNITY PROPERTY OF THE PARTIES, AND EACH OF THE PARTIES DOES HEREBY CONVEY AND TRANSFER TO THE OTHER AND TO THEIR MARITAL COMMUNITY, ALL PROPERTY HEREAFTER ACQUIRED BY EITHER OF US, EVEN THOUGH THE SAME BE ACQUIRED IN HIS OR HER SEPARATE ESTATE, AND

IT IS FURTHER AGREED THAT THE WHOLE OF THE COMMUNITY PROPERTY NOW OWNED BY US OR HEREAFTER ACQUIRED BY US, INCLUDING ALL PROPERTY THE STATUS OF WHICH IS CHANGED OR CREATED BY THIS AGREEMENT, SHALL AT ONCE, IN THE EVENT OF THE DEATH OF MARK C. LOWRY, WHILE THE SAID PEGGY B. LOWRY SURVIVES, BE VESTED IN PEGGY B. LOWRY,

ABSOLUTELY AND IN FEE SIMPLE AS HER SOLE AND SEPARATE PROPERTY; AND IN THE EVENT OF THE DEATH OF THE SAID PEGGY B. LOWRY, WHILE THE SAID MARK C. LOWRY SURVIVES, THEN THE WHOLE OF THE COMMUNITY PROPERTY NOW OWNED BY US, ORE HEREAFTER ACQUIRED BY US, INCLUDING ALL PROPERTY THE STATUS OF WHICH IS CHANGED OR CREATED BY THIS AGREEMENT, SHALL AT ONCE VEST IN THE SAID MARK C.
