At least \$100 labor was performed on or for the benefit of (on adjoining claims) each of the following claims filed in Skamania County on October 1, 1985: Eureka #1-110. At least \$800 labor was performed on each of the following claims filed in Skamania County on October 1, 1985: Lower East Fork Lewis Placer, Upper East Fork Lewis Placer, Headwaters East Fork Placer, Green Fork Placer. ORMC #85647-771. The work was performed by Scott Knepper, Daniel Newhouse, James Welch, David Ewing, Craig Kelsey, Norm Torgerson, Norman Ratcliff, Don Saunders, Erik Steinhauer and Kevin Madarash and consisted of geological surveys of the area, extensive sampling of both placer and hardrock, research on the history of the deposit, assays, metallurgical testing and other general mining work.
