Beginning at the Northeast corner of the East One-half of the Southeast Quarter of the Southwest Quarter of Section Eight (8), Township One (1) North, Range Five (5) East of the Willamette Meridian; thence West 60 feet; thence South 200 feet; thence East 60 feet; thence North 200 feet to the point of beginning.

Grantees purchased the above-described real estate from Grantors on October 21, 1975. By mistake and oversight, Grantors failed to convey said real estate to Grantees at that time. This Deed is given belatedly at this time but is intended to be effective as of October 21, 1975.

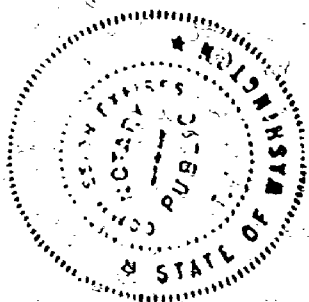
