

## EXECUTOR'S DEED

Deed made June 19, 1987, between HERBERT R. ANDERSEN, of Carson, Skamania County, Washington, herein referred to and acting as Executor of the Estate of Eddah L. Ossman, deceased, and NORMAN A. ANDERSEN, of Vancouver, Clark County, Washington, herein referred to as grantee.

## The parties recite and declare that:

1. On September 6, 1974, Eddah L. Ossman executed her will disposing of all of her property. Eddah L. Ossman died on January 24, 1985, and her will was duly admitted to probate by proper order of the Superior Court of the County of Skamania, State of Washington.

2. By the terms of the will, in Paragraph Three, certain property rights and interest were devised to said grantee.

3. The will conferred on Herbert R. Andersen, as executor, general authority to sell and dispose of any portion of the estate and to execute conveyances thereof.

4. The interest in the real estate of Eddah L. Ossman vested or to be vested in grantee by virtue of Paragraph Three of the will is of the reasonable value of Ten Thousand Six Hundred Fifty Dollars (\$10,650.00).

In consideration of the premises the executor of the Estate of Eddah L. Ossman, deceased, conveys to grantee all that certain land and premises described as follows:

One-eighth undivided interest in real property located in Skamania County, Washington, and more particularly described as follows:

From the Northeast corner of the Northwest Quarter of the Northeast Quarter of Section 20, Township 3 North, Range 8 East of the Willamette Meridian, south 82 rods from point of beginning, thence West 80 rods South 40 rods, East 80 rods, North 40 rods to point of beginning; and

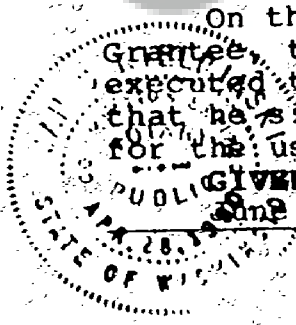
