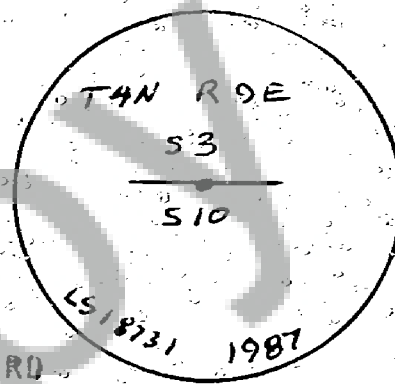

WITH THAT FOUND ON STANDARD PARALLEL. FOREST SERVICE LOCATION
POSTER #458 "A.S./MLD 1-7-47" OPENED BLAZE, FOUND SCRIBING.
27" OF STUMP, BEARS N 60° N, 11.60', WITH BLAZE, NO VISIBLE SCRIBING.
