SECOND AMENDMENT TO REAL ESTATE CONTRACT

THIS AGREEMENT, made and entered into this 28th day of october, 1987, by and between AMERICAN LEGION POST \$137 as assignee of the seller's interest in and to that certain real estate contract dated May 30, 1980, by and between HOUSING OUR PEOPLE ENTERPRISES, INC., a Washington non-profit corporation, as seller, and CASCADE PROPERTIES, a Partnership, as purchaser, recorded on June 4, 1980, under Auditor's File No. 90839, at Book 78, Page 288, and amended by agreement dated July 10, 1981, recorded under Auditor's File No. 92779, at Book 80, page 11-12 on July 14, 1981, records of Skamania County, Washington, and CARSON VILLAGE APTS., INC., a Washington corporation, as assignee of the purchaser's interest in said real estate contract, WITNESSETH:

- 1. Paragraph 1(c) of said real estate contract is hereby amended to provide that the unpaid principal balance thereof shall bear interest at the rate of eleven percent (11%) per annum computed from and after October 10, 1987; that the monthly payments shall be the sum of \$1,020.66, payable on the 10th day of each month, with the entire unpaid balance of said contract, both principal and interest, payable on or before eighteen (18) years from the date hereof.
 - 2. CARSON VILLAGE APTS., INC. agrees that the balance of said contract is owed to, and shall be paid to, AMERICAN LEGION POST #137 of Carson, Washington, as the assignee of HOUSING OUR PEOPLE ENTERPRISES, INC., and AMERICAN LEGION POST #137 accepts CARSON VILLAGE APTS., INC. as the debtor and the assignee of CASCADE PROPERTIES, a partnership, to the extent that a novation has occurred and, henceforth, the parties may deal with each other without reference to their predecessors in title.

EXCEPT AS HEREIN MODIFIED the above referenced real estate contract is reaffirmed in its entirety.
