STATUTORY WARRANTY DEED

The Grantors, MARTIN ELOI BROUSSARD, THEODORE E. JUNG and PRED C. ADAMS, JR., as Trustees of the Elizabeth Roane Jung Land Trust dated January 2, 1958, for and in consideration of the sum of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration in hand paid, conveys and warrants to THE TRUST FOR PUBLIC LAND, a non-profit California public benefit corporation, the following described real estate, situated in the County of Skamania, State of Washington:

PARCEL I

That portion of the Northwest quarter of the Southeast quarter of Section 34, Township 2 North, Range 6 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at a point South 39° East 650 feet from the center of said Section 34, thence South 28° East 168 feet; thence South 13°40' East 260 feet; thence South 29°40' East 268 feet; thence South 23° East 268 feet to the North line of Government Lot 2 of said Section 34; thence West 760 feet; thence North to the Southerly line of the S.P. & S. Railway Company's Right-of-way; thence Northeasterly along said Right-of-way to the point of beginning.


