EDITH K. WEBBERLEY, a widow, of Camas, Washington, Grantor, for the true and actual consideration of Fifty Five Thousand Four Hundred Dollars (\$55,400.00), paid by Grantee pursuant to the Columbia River Gorge National Scenic Area Act of November 17, 1986 (100 Stat. 4274; 16 U.S.C. 544g), the receipt of which is hereby acknowledged, does hereby convey and warrant unto the UNITED STATES OF AMERICA, Grantee, and its assigns, all of the following described real property situate in the County of Skamania, State of Washington.

WILLAMETTE MERIDIAN

T. 1 N., R. 5 E., W.M.,

Section 16, portion of SW1/4;  
Section 17, portion of SE1/4.

Parcel more particularly described as follows:

BEGINNING AT a point that is the PC of a road centerline, which point is South 00°08'39" East 3,041.30 feet (Washington Coord. System, South Zone) from an iron pipe at the Northeast corner of said Section 17; thence South 77°56'00" West along said centerline, 1,045.34 feet; thence along the Arc of a 50 foot radius curve to the left for an arc distance of 70.95 feet; thence South 03°22'00" East, 297.21 feet; thence along the arc of a 200 foot radius curve to the left for an arc distance of 130.38 feet; thence South 10°43'00" East, 246 feet, more or less, to the North right-of-way line of State Highway 14; thence following said right-of-way line, Northeasterly to a point which bears South 05°00'00" East from the point of beginning; Thence North 05°00'00" West, 333.84, more or less, to the point of beginning.

The area described contains 11.08 acres, more or less.

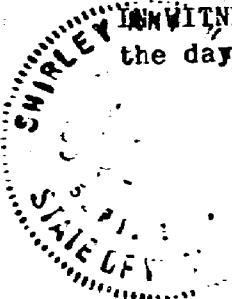
