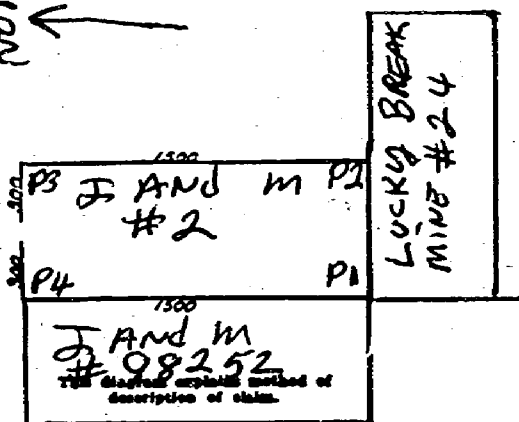

## Notice of Mining Location

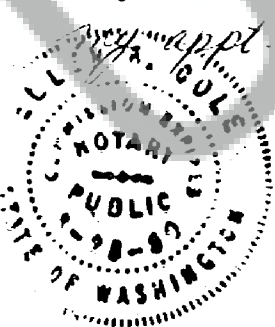
