1. History of Corner Establishment and Subsequent Restoration: 2. Description of Evidence Found:
GLO in 1880 set a post for this corner, from which bear:

16" fir, N71W, 3.30 feet

24" fir, S05W, 5.28 feet

In 1896, Skamania County Engineer H. Wetherell tied this corner during a subdivision of Section 10, but no information provided in his notes.

In 1956, L.B. Smith (LS 5125) set this corner by proportion during a staff compass survey, and set a 3/4"x30" iron pipe, from which bear:

8" fir, N05W, 18.5 feet, scribed 1/4SBT

12" fir, S88E, 23.8 feet, scribed 1/4SBT

Found iron pipe and WT's as per 1956 survey, but corner position not acceptable.
Set 5/8"x30" iron rod with plastic cap.

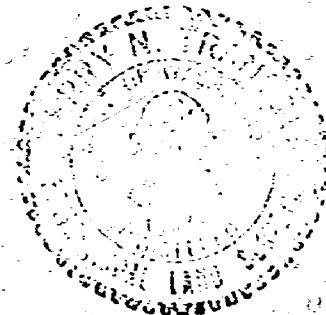
