hereby present you with my claim for damages against the County of Skamania, State of Washington, with the information required to be given by RCW 36.45.020 as follows:

1. That ~~the injury~~ for which I claim damages against the County of Skamania, State of Washington, occurred on or about the 21st day of August, 19 88.

2. That the place ~~of injury~~ was at the Skamania County Recycling Center

3. That the location and description of the defect which caused the ~~injury~~ damages are due to the Recycling Center not having the proper equipment for unloading recyclable material. (Suggestion: That the Recycling/Solid Waste Department buy the necessary equipment to establish a better unloading operation.)

4. That the ~~injury~~ is described as follows: Using a very short chain and the scoop to remove a pressure water tank from my pickup, the scoop evidently dropped the tank on the tail gate, damaging the tail gate to the point that it will not lock and secure as before.

5. That the amount of damages claimed is as follows: to replace with a used tail gate and repaint would cost between \$150.00 and \$250.00

6. That the actual residence of the claimant at the time of presenting and filing this claim is Berge Road, Home Valley, WA.

7. That the actual residence of the claimant for a period of six months immediately prior to the time that this claim accrued was Berge Rd., Home Valley, WA
