

CLAIM OF LIEN

WIND RIVER LOGGING COMPANY, Claimant, vs.
MENASHA CORPORATION

NOTICE IS HEREBY GIVEN that WIND RIVER LOGGING COMPANY, of Skamania County, State of Washington, claims a lien upon certain logs, being approximately 2.3 million board feet in quantity in the "Huckleberry" sale (Unit #1), and approximately 150,000 board feet in quantity in the "Huckleberry" Sale (Unit #2), which were cut or manufactured in Skamania County, Washington, are unbranded, and are now lying in portions of Sections 14, 23 and 26, T3N, R6 E.W.M., within the marked sale area boundaries, tags and property lines, for the furnishing of all equipment, materials, supplies and labor performed upon and assistance rendered in rocking and maintaining certain logging roads in the sale area. The amount owed for said materials, labor, and equipment is \$6,480.00. And, for falling and bucking logs in Unit #1 of said sale area in the total amount of 2.3 million board feet of logs at a price of \$13.50 per thousand board feet, and for falling and bucking logs in Unit #2 in the total amount of 150,000 board feet at \$9.00 per thousand board feet; that the owner of the real property is the State of Washington; and that the name of the owner of the sale contract is MENASHA CORPORATION, a Wisconsin Corporation; that MENASHA CORPORATION contracted with WIND RIVER LOGGING COMPANY to furnish such equipment, materials and supplies, and to perform such labor and render such assistance; that said contract has been faithfully performed and fully complied with on the part of said WIND RIVER LOGGING COMPANY, who furnished said equipment, material and supplies, and performed such labor and assistance in falling and bucking said logs for the period of approximately four months; that said services were so performed and rendered upon said logs between April, 1988, and August 31, 1988, and the rendition of said services was closed on or about the 31st day of

August, 1988, and sixty (60) days have not elapsed since that time; that the amount of claimant's demand for said services is \$6,480.00 for road maintenance and repairs, and the sum of \$13.50 per thousand board feet times 2.3 million board feet, and the sum of \$9.00 per thousand board feet times 150,000 board feet; that no part of each of said sums has been paid and that all of said monies listed above are now due and owing after deducting all just credits and offsets, the claimant claims a lien on all of said logs now owned by MENASHA CORPORATION, a Wisconsin corporation, Land & Timber/Wood Fibre, 2405 Evergreen Park Drive., Suite B-3, Olympia, WA 98502, to secure payment for the equipment, material and supplies furnished, and the work and labor performed in obtaining or securing the said logs, spars, piles, or other timber, lumber, or shingles herein described, and for the road maintenance and repairs.
