

ASSIGNMENT OF TRUST DEED BY BENEFICIARY

The undersigned hereby covenants to and with said assignee that the undersigned are the beneficiaries or their successors in interest under said trust deed and are the owners and holders of the beneficial interest therein; that they have good right to sell, transfer and assign the same, and the note or other obligation secured thereby, and that there is now unpaid on the obligations secured by said trust deed the sum of not less than Seventeen Thousand Five Hundred and No/100ths Dollars (\$17,500.00), with interest thereon from August 17, 1988.

In construing this instrument and whenever the context hereof so requires, the masculine gender includes the feminine and the neuter and the singular includes the plural.

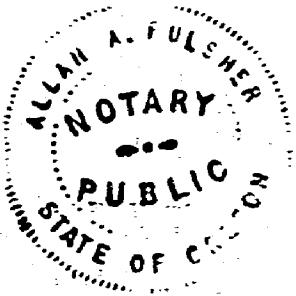
