GRANTOR(S) Stanley W. Anderson

for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable considerations (\$ 10.00 ) Dollars, to us in hand paid, and in further consideration of the general public welfare, do by these presents grant, convey and dedicate to Skamania County, State of Washington, for the use of the public as a county road and appurtenances the following described real property in the County of Skamania, State of Washington:

A right-of-way as required for Sooter Road (County Road No. 32470). Said right-of-way is in the Ruby Sooter short plat in the northeast quarter (N.E. 1/4) of Section 22, Township 3 North, Range 10 East of Willamette Meridian. More particularly described as follows:

Beginning at the point of beginning of the short plat which is the southern most corner of lot number 4, thence N46°51'59"E 67.27 feet along the existing north right-of-way line of the Sooter Road, County Road No. 32470. Thence N26°24'27"W 31.33 feet along the line between lot number 4 and lot number 1. Thence S46°51'59"W 63.10 feet more or less to the southwesterly line of the short plat, thence S28°30'44"E 18.20 feet along said line of the short plat. Thence S08°25'01"E 15.08 feet to the point of beginning of this right-of-way and the point of beginning of the short plat.
