NOTICE IS HEREBY GIVEN that DAVID D. BLACKWELL d/b/a J and D
TIMBER FALLING, of Skamania County, State of Washington, claims a
lien upon certain felled timber, being about 2.3 million board

is Menasha Corporation, a Washington corporation; that Menasha
Corporation employed Wind River Logging Company, a Washington
corporation, as its agent, and Wind River Logging Company employed
claimant, David D. Blackwell d/b/a J and D Timber Falling, to
perform such labor and render such assistance upon the terms and
conditions set forth in Exhibit "A" attached hereto.

Blackwell d/b/a J and D Timber Falling for such labor and assistance \$13.50 per thousand board feet; that said contract has been faithfully performed and fully complied with on the part of said claimant, who performed labor with respect to falling and bucking said timber for the period of 71 days; that said labor and assistance were so performed and rendered upon said timber between the 22nd day of March, 1988 and the 19th day of August, 1988; and the rendition of said service was closed on the 19th day of August, 1988, and sixty days have not elapsed since that time; that the amount of Claimant's demand for said service is \$31,050.00; that no part thereof has been paid except \$9,000.00, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$22,050.00, in which amount he claims a lien upon said timber. The said Claimant, David D. Blackwell d/b/a/ J and D Timber Falling, also claims a lien on all said timber now owned by said Menasha Corporation of Skamania County to secure payment for the work and labor performed in obtaining or securing the said timber herein described.
